MINUTES OF THE ANNUAL GENERAL BODY MEETING OF THE INDIAN COMMERCE
ASSOCIATION HELD ON DECEMBER 21, 2018

The Annual General Body Meeting of the Indian Commerce Association was held on December 21, 2018 at 4.00 pm in the Tagore Auditorium, Osmania University, Hyderabad, under the chairmanship of Professor Manas Pandey, Executive Vice-President of ICA (In the absence of President ICA). The following decisions were taken unanimously:

Item 1 Considered the minutes of the last meeting of the General Body of the ICA held October 13, 2017 at 4.30 pm in the Conference Hall (Dome) IIS University, Jaipur, under the chairmanship of Professor Arvind Kumar, President of ICA.

RESOLVED to approve the minutes of the last General Body Meeting of the ICA.

Item 2 Considered the Secretary's Report for the year 2018 as approved by the Executive Committee of the ICA

RESOLVED to approve the Secretary's Report for the Year 2018.

Item 3 Considered the recommendation of Executive Committee regarding audited accounts of the ICA for the year 2017-18 and the Managing Editor's Report.

Item 5 To report the recommendations of the Executive Committee of the ICA that the General Body be given opportunity to elect the hosts of 72nd ICA Conference and they be informed about the institutions from where the proposals have come along with the proposed Conference Secretary's name.

RESOLVED to approve the recommendations of the EC that in the absence of any proposal for hosting 72nd Annual Conference of ICA, the Office Bearers be authorized to explore the possibilities and to finalise the venue of the 72nd AICC.

Item 6 Considered the recommendation of Executive Committee of ICA regarding appointment of Returning Officer for 2019 ICA elections.

RESOLVED to appoint Prof. P. Purushotam Rao as the Returning Officer for conducting Elections scheduled to be held during the 72nd All India Commerce Conference in 2019.

Item 7 Considered the recommendation of Executive Committee of ICA regarding appointment of auditor.

RESOLVED to appoint M/S J.Kumar Grover & Co, Chartered Accounts as Auditor for the year 2018-19 on the mutually agreed upon terms and conditions.

Item 8 To confer the honor of the Fellow of the Indian Commerce Association to the Chairpersons of the various Sessions of the 71st All India Commerce Conference and the new members of the EC of the ICA for their contributions made to the ICA in particular and academics in general in terms of the Resolution No 10 of the General Body Meeting of the ICA held on December 28, 2004 at Indore.
